### NEW BUSINESS

1. Newsletter

The Board discussed the yearly newsletter. Each member will submit their sections on December 1<sup>st</sup>, and David will assemble, print and mail out.

#### 2. Yearly association dues, late fees

The Board reviewed the association's annual budget, and will include the proposal in the newsletter. The Board determined that the yearly dues for 2019 will be set at \$1200/lot. The Board also established a new late fee plan, including \$25 for the first instance, \$35 for a second instance, and \$50 for a third late payment or beyond. Late fees will be assigned for any bill due the association.

#### **OLD BUSINESS**

### 1. Monument Lighting Project

David Brookshire discussed the challenges uncovered in trying to build a solar-only solution for lighting our entrance monuments. There is currently no economical method for providing power necessary, short of paying CenterPoint to build out new service panels for each monument. The Board will follow up with CenterPoint regarding their offer to install a new street light by the second monument, and converting all of the subdivision lights to LED.
